

PR Photos Terms and Conditions For Photographers & Contributors

Agreement Terms & Conditions

By registering as a photographer on the PR Photos website, and checking the box that you agree to the terms and conditions of this agreement you are entering into a contract granting PR Photos a license to syndicate the picture(s) worldwide and showcase these pictures on the PR Photos websites in-perpetuity. This agreement is made between you, the photographer and information provided on our registration page, and PR Photos 4521 PGA Blvd. #336 Palm Beach Gardens, FL 33418.

Photographers Copyright Guarantee

By registering and submitting to PR Photos you confirm that you own the copyright to the picture(s) that you will be supplying to PR Photos. The photographer is the sole and exclusive owner of, and has the sole and exclusive right to license, all photographs submitted to the PR Photos and the photographer has obtained all permissions necessary for PR Photos to lawfully license the Photographs. If for any reason the photographer submits photographs that infringe on any other persons copyright, that photographer will be terminated immediately in accordance with the DMCA policies.

Photographers Compensation

Photographer understands and accepts that all sales revenue received by PR Photos will be split 50/50. All sales will be paid to you via a monthly collection report. You will receive your royalty payments the month after the actual payment has been received by PR Photos from its client or sub-agent. If Photographer's fees in any one month total less than twenty-five dollars (\$25.00), the Agency may postpone payment until the next month, or until such time as Photographer's fee exceeds twenty-five dollars (\$25.00).

Law Governing & Arbitration

By entering into this agreement you, the photographer, agree that the laws of the State of Florida, without regard to principles of conflict of laws, will govern these Terms and Conditions and any dispute of any sort that might arise between you, the photographer, and PR Photos or any of our affiliates. With respect to any disputes or claims not subject to arbitration (as set forth below), you agree not to commence or prosecute any action in connection therewith other than in the state and federal courts of Florida, and you hereby consent to, and waive all defenses of lack of personal jurisdiction and forum non conveniens with respect to, venue and jurisdiction in the state and federal courts of Florida. The photographer and PR Photos agree and accept that the sole and exclusive remedy for all disputes and claims shall be final and binding arbitration. Arbitration under this agreement shall be conducted by the American Arbitration Association (the "AAA") under its Commercial Arbitration Rules. In no event shall any claim, action or proceeding by you related in any way to the Site and/or the Service be instituted more than three (3) years after the cause of action arose.

Digital Signature

By checking the box on our photographers registration page the photographer has attached their electronic digital signature to and agrees to these terms & conditions of the PR Photos Web site and services. This is a legally binding agreement between the photographer and PR Photos.
